

Appendix B

Classification of Pharmaceutical Products

Pharmaceutical products fall within Chapter 30 of the Tariff Codes. These products are divided into six categories: 30.01, 30.02, 30.03, 30.04, 30.05, and 30.06. What follows is the definition of each category.
